STRUCTURAL DESIGN AGREEMENT:

- √ This agreement is for design layout and analysis services for the renovation or construction of a dwelling as defined. M H Leonard Consulting Engineers, PA agrees to do the requested scope of work at our current engineering service rates and/or for a quoted fee
- √ The <u>layout</u>, <u>design work and specifications</u> will be submitted back to you on or before the DESIGN DUE DATE specified subject to adjustments if applicable. You will be notified if the structural design is on or off schedule with reasons or issues identified within a few days of our start date.
- ✓ If you are transferring the information to other baseline drawings, the date the design drawings are ready for certification and sealing will be determined by your turnaround time. We must have adequate time for final review (at least 24 hours) - without exception.

DOCUMENT and MISC. DESIGN DETAILS AGREEMENT: ✓ If the county review or building codes where the dwelling is to be built require other specific information or diagrams, that work is done under the separate DOCUMENT AGREEMENT. ✓ If MHLCE is generating structural drawings (part of the design documents), the DOCUMENT DUE DATE will be specified and is usually later than the DESIGN DUE DATE. ✓ If existing conditions warrant field investigation, a separate inspection agreement will be provided BEFORE that work is done.
